"GoodOneProductions" shall be referred to as "Studio" within this contract.

TIME

Official time begins upon commencement of shooting (bride's preparations, etc.), or one hour prior to the scheduled ceremony (when we setup our cameras, microphones, etc.), whichever is earliest, and time shall run continuously until departing the event location.

If the total job time exceeds the time contracted for, extra charges will apply at _____ / hr (rate and by the policy as shown on our website).

CANCELLATION

In the event of a postponement or cancellation of this contract, so long as a minimum of thirty days notice has been given to Studio, the deposits paid may be used for any future event up to one year past the date of this contract, providing Studio has no other obligations for the future date. After that time, all deposits will be forfeited to Studio.

If Client gives less than thirty days notice of cancellation or postponement but more than two days, a \$250 Cancellation Fee will be charged plus trip fees, if any trips have already been made. If notice of cancellation is received after Studio has left for the rehearsal or event, the deposit and payment of first half of total fee will be considered "earned", but the last half of total (if already paid) will be refunded.

CHANGES

The Client has had opportunity to critically view samples of the Studio's video work and has retained the Studio as the exclusive official videographer to cover this event. The Client grants Studio full production and editorial control regarding all aspects of this production and postproduction.

Client may request one set of changes, upon receiving his approval copy. If such changes require more than one hour of editing time, such extra time shall be billed at \$99 per hour. Such changes must be requested by email or other written form, by the time specified on the approval video (usually several days).

When requested changes are completed to the best of our ability, final DVD copies will be produced. No additional Approval Copies will be mailed. If no changes are received by that deadline date, it will be assumed that the client is satisfied with the DVD AS IS and NO changes will be made to the final copy. We cannot keep huge video files on our computer longer than ten days from the time we send your Approval Copy, so if changes are requested after the deadline, substantial editing charges will apply.

Studio takes utmost care with respect to the exposure, sound capture, editing, duplication and delivery of the video products and services offered. However, in the event Studio fails to

comply with the terms of this contract due to any event or act, the Studio's liability is limited to the refund of monies paid to Studio.

PRODUCTION MATERIALS

The Studio must receive photos, invitations, music, checklists, and any other materials that client would want used in this production, by wedding day. Production may proceed without such materials if not supplied by this time.

RIGHTS

Client warrants that he/she has the legal rights to anything the Studio will videotape, including photos, music or other materials supplied by the client for use in this video, and consent of all attending guests and participants, and that client's use will be limited to viewing by friends and family.

Studio reserves the right to use the original video tape and/or reproductions for display, promotion, publication or other purposes, otherwise notice and an additional fee of \$500 must be made by client prior to wedding date.

Studio reserves the right to remove themselves and all equipment at any time there appears to be a potential danger to themselves or equipment (belligerent or rowdy, intoxicated people; improper fireworks; careless discharge of firearms; etc.). No refund or other consideration shall be given in such cases.

For outdoor weddings studio utilizes proper equipment to reduce wind noise (fur muffs) and utilizes camera rain covers in the case of a drizzle or light rain. However, Studio reserves the right to immediately remove all equipment to an indoor location in the event of weather that may be hazardous to equipment or persons like lightning, strong wind, hard rain, etc.. No refund or reduction in price shall occur in this event but, hopefully, the event would be moved indoors where video could be continued.

TRAVEL

There is no travel fee within the State of Tennessee and certain areas near the State border, for the purpose of attending rehearsal and the wedding day, if the wedding day immediately follows the rehearsal date. This means that, for most weddings in the State of Tennessee or in some surrounding areas, there is never a travel fee unless extra trips are requested.

For all other travel, a mileage fee of fifty cents per mile for each trip made by Studio will be prepaid by Client for every mile outside of Murfreesboro, TN. Travel for location weddings (outside of our normal coverage area) must be agreed upon and included in a written addendum to this agreement.

DESCRIPTION

Wedding Packages:

Ceremony Only -- \$475

One 3-CCD Camera/One Videographer

Three hours of coverage, covering the ceremony. Starting a 1 hour before the ceremony and finishing 1 hour after the ceremony. Edited and transferred to DVD with the names of the couple at the beginning.

Reception Only -- \$575

One 3-CCD Camera/ One Videographer

Five hours of coverage, covering the reception only. Starting a 1/2 before cocktail hour, we usually cover the typical events; intros, toasts, cake cutting, first dance, father daughter dance, bridal party dance, bouquet toss and whatever other dancing occurs within the five hours. Edited and transferred to a DVD with menu chapters using up to two songs.

No Editing Package -- \$675

One 3-CCD Camera/ One Videographer

Eight hours of coverage, covering the pre-ceremony (at the church), Ceremony and Reception. (Up to 8 hours max. from first set-up until final break-down.) All the raw footage is transferred to DVD and you get a copy of the mini-dv tapes.

Economy Package -- \$750

One 3-CCD Camera/ One Videographer

Seven and a half hours of coverage, covering the ceremony and reception. Wireless audio for the vows, editing, end titles, up to three songs and two DVD copies with menu chapters. Final video 85 minutes in length. (Up to 7.5 hours max. from first set-up to final break-down.)

Single Camera Package -- \$850

One 3-CCD Camera/ One Videographer

Eight and a half hours of coverage, covering the pre-ceremony (at the church), Ceremony and Reception. Wireless audio for vows, including editing, and end titles, up to three songs and two DVD copies with menu chapters. Final video 90 min. long. (Up to 8.5 hours max. from first set-up until final break-down.)

Special Package -- \$925

Two 3-CCD Cameras/ One Videographer (One camera manned, one unmanned during ceremony.)

Nine and a half hours of coverage, covering the pre-ceremony (at the church), Ceremony and Reception. Wireless audio for vows, including editing, end titles, up to three songs and three DVD copies with menu chapters. Final video 110 min. long. (Up to 9.5 hours max. from first set-

up until final break-down.)

Elite Package -- \$975

Two 3-CCD Cameras/ Two Videographers

Nine and a half hours of coverage, covering the pre-ceremony (at the church), Ceremony and Reception. Post ceremony photo session at the church. Wireless audio for vows, including editing, end titles with a short recap. Up to three songs and four DVD copies with menu chapters. Final video 120 min. long. (Up to 9.5 hours max. from first set-up until final break-down.)

Basic Package --\$1075

Two 3-CCD Cameras/Two Videographers

Nine and a half hours of coverage, covering the pre-ceremony (at the church), Ceremony and Reception. Post ceremony photo session at church and 2nd location if time permits. Wireless audio for vows, including editing, recap, end titles, photo montage using your photos up to 50, already scanned, up to five songs and three DVD copies with menu chapters. Final video 120 min. long. (Up to 9.5 hours max. from first set-up until final break-down.)

Deluxe Package-- \$1175

Two 3-CCD Cameras/Two Videographers

Ten Hours of coverage, covering the bride getting ready at a 2nd location, Ceremony and Reception. Post ceremony photo sessions. Wireless audio, editing, photo montage using your photos, up to 65 already scanned, interviews of the bridal party and family by request only, up to five songs, recap, end titles, three DVD copies with menu chapters. Final video 120 min. long. (Up to 10 hours max. from first set-up to final break-down.)

Bronze Package -- \$995

Two HD Video Cameras /One Videographer (One camera manned, one unmanned during ceremony.)

Nine hours of coverage, covering the pre-ceremony (at the church), Ceremony and Reception. Post ceremony photo session at church and 2nd location if time permits. Wireless audio for vows, including editing, recap, end titles, up to five songs and two DVDs and two Blu-ray DVDs with menu chapters. Final video up to approx. 90 to 120 min. long. (Up to 9 hours max. from first set-up until final break-down.)

Ruby Package -- \$1175

Two HD Video Cameras/Two Videographers

Nine Hours of coverage, the Ceremony and Reception. Post ceremony photo sessions. Wireless audio, editing, end titles, up to six songs, recap. Two DVDs and two Blu-ray DVDs with menu chapters. Final video up to approx. 120 min. long. (Up to 9 hours max. from first set-up to final break-down.)

Silver Package -- \$1250

Two HD Video Cameras/Two Videographers

Ten Hours of coverage, covering pre-ceremony of the bride getting ready, the Ceremony and Reception. Post ceremony photo sessions. Wireless audio, editing, end titles, up to six songs, recap, photo montage using your photos up to 50 already scanned. Interviews of the bridal party and families. Two DVDs and two Blu-ray DVDs with menu chapters. Final video up to approx. 120 min. long. (Up to 10 hours max. from first set-up to final break-down.)

Gold Package-- \$1375

Two HD Video Cameras/Two Videographers

Eleven hours of coverage of the bride & groom getting ready at a 2nd location, Ceremony, Post-ceremony Photo sessions and the Reception. Wireless audio, editing, photo montages using your photos up to 65 already scanned, interviews of the bridal party and family, recap, end titles, up to seven songs, two DVDs and two Blu-Ray DVDs with menu chapters. Final video up to approx. 120 minutes long. (Up to 11 hours max. from first set-up to final break-down.)

Diamond Package-- \$1575

Two HD Video Cameras/Two Videographers

Twelve hours of coverage, covering the bride & groom getting ready at a 2nd location, Ceremony, Post-ceremony Photo sessions at the church and 2nd location, and the Reception. Wireless mikes, editing, photo montages using your photos up to 75 (free scanning), interviews of the bridal party and family, end titles, and recap, up to seven songs, four Blu-Ray DVD and two DVD with menu chapters. Final video up to approx. 120 minutes long. (Up to 12 hours max. from first set-up to final break-down.)

Time begins 1 hour before ceremony or at start of video coverage, whichever is earlier (due to time required for setup of cameras and microphones, etc.) We attend rehearsals (1hr) at no charge, if they are held the day of or the day prior to the ceremony.

Extras:

- Extra trips, \$99 each + mileage. (Rehearsal & wedding day do not count if on consecutive days, thus we nearly never have this charge).

Note: extra trips will not be necessary unless you have special requests.

- Extra time, \$199/hr if prepaid, \$250/hr otherwise. (Note: You can do a “make believe” exit to allow the photographers and videographers to leave, then continue the party.)

- No travel or mileage charges unless otherwise noted in writing or email.

Note: if video greetings are to be done you must –

1. assign someone to gather up the greeters at the appropriate time
2. make a somewhat quiet room available just off the main room
3. allow 30-40 minutes where no other events are occurring

You will receive beautifully edited wedding DVD's or Blu-Ray videos - your choice. Extra copies are just \$30 each for Blu-Ray and \$15 each for DVD, special set of 10 DVDs is \$100, set of 30 DVD's is \$250. Purchase the full set of original tapes (raw footage) for just \$299.

PAYMENT:

One half of the balance of the video fee (after deposit) must be received no less than ten days prior to the rehearsal. For instance, for a \$1999 wedding plan, if a \$199 deposit has been paid, half the \$1800 remaining balance (\$900) must be paid at least 10 days prior to the wedding rehearsal or earliest shooting day (if earlier), else the reservation shall be considered cancelled without further notice. The final balance is due within ten days of receipt of the Approval Copy unless payment terms have been pre-arranged. We cannot keep huge video files on our computer longer than ten days from the time we send your approval copy, so if changes are requested after that time, extra editing charges will apply.
